Release of Sponsor: Release from Liability and Waiver of Responsibility. If contestant is under 21* years of age, both contestant and parent or legal guardian must sign this form As a condition to participate in this event. The TSCC, its director, officer, representative, member, volunteer and/or sponsors ARE HEREBY RELEASED from all claims, demands, or causes of action of any kind or nature whatsoever; whether now existing or to hereafter accrue, or account of any damage, cost or expense. (I) AS A RESULT OF ANY BODILY INJURY, LOSS OR DAMAGE TO ANY ANIMALS, EQUIPMENT OR OTHER PERSONAL PROPERTY FROM ANY CAUSE WHATSOEVER INCLUDING, BUT NOT LIMITED TO, THE SOLE OR CONCURRENT NEGLIGENCE OF TSCC, ITS DIRECTORS, OFFICERS, REPRESENTATIVES, MEMBERS OR SPONSORS; or (II) as a result of the interpretation or enforcement of the TSCC Constitution, Bylaws, Rules or Regulations and the risk of any such damage, cost or expense which may occur
